1. The office of the Chhatrakot Rural Municipal Executive, Choyaga, Gulmi invites sealed quotations from registered Suppliers for the **Supply and Delivery of Essential Drugs (Medicine)**.
2. Eligible Bidders may obtain further information and inspect the Bidding Documents at the Office of the Chhatrakot Rural Municipal Executive, Choyaga, Gulmi.
3. A complete set of Bidding Documents may be purchased from the Office of the Chhatrakot Rural Municipal Executive, Choyaga, Gulmi by eligible Bidders on the submission of a written application, along with the copy of company/firm registration certificate; and upon payment of a non-refundable fee of NRs.1000 till 20 Baisakh, 2076 during office hours.
4. Sealed bids must be submitted to the Office of the Chhatrakot Rural Municipal Executive, Choyaga, Gulmi on or before 12:00 noon, 21 Baisakh, 2076. Bids received after this deadline will be rejected.
5. The bids will be opened in the presence of Bidder's representatives who choose to attend at 01:00 PM, 21 Baisakh, 2076 at Office of the Chhatrakot Rural Municipal Executive, Choyaga, Gulmi. Bids must be valid for a period of 45 days from the date of bid opening and must be accompanied by a bid security issued by "A" class Commercial Bank approved by Nepal Rastra Bank confirming to standard format as specified in bid document, amounting to a minimum of NRs. 30,000 (in words Rupees thirty Thousand), which shall be valid for 30 days beyond the validity period of the bid. If Bidder wishes to submit the Cash Security, the cash should be deposited in:  
**Dharauti Account No.3010303007105 at Rastriya Banijya Bank, Branch Office Tamghas, Gulmi** and submit the original receipt of the deposited amount of cash along with the Sealed Quotation.
6. If the last date of purchasing and/or submission falls on a Government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
7. The purchaser reserves the right to accept or reject, wholly or partly any or all the Sealed Quotations without assigning any reason, whatsoever.
