1. The Office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal invites electronic bids from Nepalese eligible bidders for Works as mentioned below under National Competitive Bidding procedures.
2. Eligible Bidders may obtain further information at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal and inspect the bidding document at PPMO website www.bolpatra.gov.np/egp.
3. Bidders who choose to submit their bid electronically should submit their bid through bolpatra.gov.np/egp. Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Office's Rajaswa (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 4. Pre-bid meeting shall be held at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal at 27 November, 2020, 14:00 hours.
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 14 December, 2020, 12:00 noon. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 14 December, 2020 14:00 hours at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal.
7. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to deposit Bid Security as cash should deposit at Ga-3-DHARAUTI KHATA Acc no. 1170000004GE maintained at Century Commercial Bank Ltd., Chhatrakot Branch in the name of Chhatrakot Rural Municipality and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids..
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
9. Eligibility Criteria - Construction Experience in key activities: Participation as Prime contractor, management contractor, or subcontractor, in at least One Contract of government project of Overhead Water Tank Construction work within the last ten (10) years, following key activities have been successfully or are substantially completed.
 - i) RCC works in water supply project for construction of reservoir = 66.24 cum
 - ii) Reinforcement works in water supply project for construction of reservoir = 14517.61 Kg
 - iii) Election of poles in HT Line = 39 nos.
 - iv) Stringing of conductor in HT Line = 6 Km
 - v) Installation of transformer = 2 nos.
