1. The office of Chhatrakot Rural Municipal Executive, Choyaga, Gulmi invites electronic bids from eligible bidders (as per Section V of the bidding document) for the work mentioned below under National Competitive Bidding – Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 4,55,00,000.**
- Minimum Work experience of similar size and nature: **3 Years**

2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate sealed envelopes, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn as per the provision of ITB 21 of the Bidding Document.

5. Bidders who choose to submit their bid electronically should submit their bid through [bolpatra.gov.np/egp](http://bolpatra.gov.np/egp). Bidders, submitting their bid electronically, should deposit the cost of bidding document in the Office's Rajaswa (Revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids. 8. The bids will be opened in the presence of Bidders' representatives who choose to attend at **14:00 Hrs. on 04-03-2021** at the office of Chhatrakot Rural Municipal Executive, Choyaga, Gulmi.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as mentioned below, which shall be valid for 30 days beyond the validity period of the bid.
