1. The **Office of Chhatrakot Rural Municipal Executive, Choyaga, Gulmi** invites electronic bids from Nepalese eligible bidders for Work as mentioned below under National Competitive Bidding - Single Stage Two Envelope Bidding procedures.

Only eligible bidders with the following key qualifications should participate in this bidding:

- Minimum Average Annual Construction Turnover of the best 3 years within the last 10 years: **NRs. 3,14,00,000.**
  - Minimum Work experience of similar size and nature: **NRs. 84,00,000.**
2. Under the Single Stage, Two Envelope Procedure, Bidders are required to submit simultaneously two separate Bids, one containing (i) the Technical Bid and the other (ii) the Price Bid, both in turn as per the provision of ITB 21 of the Bidding Document.

Bidders should submit their bid electronically through [bolpatra.gov.np/egp](http://bolpatra.gov.np/egp) and deposit the cost of bidding document in the Office's Rajaswa (Revenue) account as specified above. 

Bids must be valid for a period of **90 days** after opening and must be accompanied by Cash Security or Bank Guarantee, amounting as amount mentioned above which shall be valid for **30 days** beyond the validity period of the bid.
