3. Bidders who choose to submit their bid electronically should submit their bid through bolpatra.gov.np/egp. 4. Pre-bid meeting shall be held at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal at 23 December, 2020, 14:00 hours for Kalikanagar-Bokhar-Manbhak-Sunartola-Galfakot Mo.Ba. and 15:00 hours for Pipelneta-Digam-Dharampani-Mankot-Daungha-Pharsatakura Mo.Ba.
5. Electronic bids must be submitted through PPMO website www.bolpatra.gov.np/egp on or before 08 January, 2021, 12:00 noon. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 08 January, 2021 14:00 hours for Kalikanagar-Bokhar-Manbhak-Sunartola-Galfakot Mo.Ba. and 14:30 hours for for Pipelneta-Digam-Dharampani-Mankot-Daungha-Pharsatakura Mo.Ba. at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Lumbini Province, Nepal.

Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting as mentioned below, which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to deposit Bid Security as cash should deposit at DHARAUTI KHATA Ga-3-1170000004GE maintained at Century Commercial Bank Ltd., Chhatrakot Branch in the name of Chhatrakot Rural Municipality and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids..
8. If the last date of purchasing and /or submission falls on a government holiday, then the next working day shall be considered as the last date. In such case the validity period of the bid security shall remain the same as specified for the original last date of bid submission.
