CRM/Gul/G/SQ-07/078-79, the Bidders/Fabricators must have experience of successfully completing Fabrication and Supply of Steel Parts for minimum 5 (five) Trail Bridges within last 5 (five) years. New fabricators may apply in joint venture with an eligible firm having the required experience. Fabricators who are not enlisted by DoLI may also apply. However, bids of such fabricators shall be considered responsive only in case fabricators fulfil the requirements.
4. Pre-bid meeting shall be held at the Office of Chhatrakot Rural Municipality, Choyaga, Gulmi on **17 December, 2021, 13:00 hours** for Contract no. CRM/Gul/W/NCB-04/078-079.
5. Bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before **12:00 hours** on **19 December, 2021** for Contract no. CRM/Gul/G/SQ-07/078-79 and **02 January, 2022** for Contract no. CRM/Gul/W/NCB-04/078-079. Bids received after this deadline shall not be accepted.
6. Bids must be valid for a period of **45 days** after bid opening for Contract no. CRM/Gul/G/SQ-07/078-79 and **90 days** for Contract no. CRM/Gul/W/NCB-04/078-079 and must be accompanied by Cash Security or Bank Guarantee, amounting as mentioned above which shall be **valid for 30 days** beyond the validity period of the bid.
