Bidders, submitting their bid electronically, should deposit the cost of bidding document i.e. NRs. 3000 in the Office's Rajaswa (revenue) account as specified below and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids.

4. Pre-bid meeting shall be held at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi Province Five, Nepal at 15-10-2020 13:00 hours.
5. Electronic bids must be submitted through PPMO website [www.bolpatra.gov.np/egp](http://www.bolpatra.gov.np/egp) on or before 01-11-2020, 12:00 noon. Bids received after this deadline will be rejected.
6. The bids will be opened in the presence of Bidders' representatives who choose to attend at 01-11-2020 13:00 at the office of Chhatrakot Rural Municipality, Choyaga, Gulmi, Province Five, Nepal.
7. Bids must be valid for a period of 90 days after bid opening and must be accompanied by a bid security or scanned copy of the bid security in .pdf format in case of e-bid, amounting to a minimum of NRs. 125000.0, which shall be valid for 30 days beyond the validity period of the bid. If the bidder wishes to deposit Bid Security as cash should deposit at DHARAUTI ACCOUNT Ga-3-1170000004GE maintained at Century Commercial Bank Ltd., Chhatrakot Branch in the name of Chhatrakot Rural Municipality and the scanned copy (pdf format) of the Bank deposit voucher shall be uploaded by the bidder at the time of electronic submission of the bids..
